Pella Cooperative Electric will send one student on an allexpenses paid Youth Tour trip to Washington, D.C. in June.

At PCEA, one way we invest in the next generation of rural lowa leaders is by participating in the National Electric Cooperative Youth Tour program. We're looking for high school sophomores or juniors with a passion for government and public service to apply for a once-in-alifetime trip to our nation's capital in June.



One student will be selected from eligible candidates to attend the 2024 Youth Tour in

Washington, D.C., from June 15-21 along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as an American citizen. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums, and historical landmarks. Students who go on Youth Tour often call it the trip of a lifetime!

We are accepting Youth Tour applications through March 22. Children of PCEA member-consumers are eligible to apply. The student must be a current sophomore or junior or currently hold the status equivalent to a sophomore or junior in an accredited home-based school. ## A New Look for SmartHub Coming Soon

In February, PCEA will be launching a new look for our online account management tool - SmartHub. All while keeping the functionality you have come to expect.

SmartHub allows you to manage your PCEA account at anytime from anywhere. Pay your bill online. View an image of your bill. View your billing history. Update your contact information. View daily usage. Sign up for email, text and mobile notifications.

When you log in, you'll be able to view your billing history and easily make a payment. You will also be able to see your current bill, along with bills from the previous month or even the previous summer, if you want to

compare costs. Not only will you see your billing history, but you'll be able to view your actual electricity use. You can see how your usage is trending over time, which will allow you to take steps to reduce your consumption and lower your monthly bill.

SmartHub is available through Pella Cooperative Electric's website and as a free mobile app through the Apple App Store (iOS devices) or Google Play Marketplace (Android devices).

## 2023 Annual Meeting Minutes



The Annual Meeting of the Members of the Pella Cooperative Electric Association was held at the Pella Christian High School in Pella, Iowa at 6:30 p.m. on the 4th of April 2023.

Duane Ver Ploeg, President of the Cooperative, presided and called the meeting to order.

Bryce Arkema, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

Shortly after the meeting convened, it was called off due to the severe weather conditions unfolding, including the threat of tornado activity. Members were strongly urged to return to their homes. It was announced prior to the members' departure that the Board President's and CEO's reports to the members would be videotaped and made available on the Cooperative's website, as well as Director election results. The Nominating Committee's report would also be shown on the subject video report, as would the Notice of this annual meeting.

There were at least 50 members of the Cooperative in attendance, which consititued a quorum of the members of the Cooperative.

The Nominating Comittee's report showed the following nominations of members for directors:

The Certificate of Inspectors of Election will be annexed to the minutes of this meeting, and therupon such members duly elected Directors of the Cooperative will hold office for the term specified and until their successors shall have been elected and qualified.

As members departed for home, President Ver Ploeg declared on motion made, seconded, and carried the meeting adjorned.

The PCEA Board of Directors met on December 28 for the December board meeting and discussed the following:

- The Board of Directors approved the operating and capital expenditures budget for 2024.
- The Operations Department updated the Board of Directors on the status of the MidAmerican transmission line upgrade that supplies power to the Otley and West Pella substations.
- In accordance with Article III, Section 3 of the Cooperative's bylaws, the Board of Directors formally appointed the 2024 Nominating Committee. The Nominating Committee will meet on Thursday, January 18 to select candidates to run for District 2 and one open At-Large position.
