We're Accepting Applications for High School Leadership Trip to D.C.

Pella Cooperative Electric will send one student on an all-expenses paid Youth Tour trip to Washington, D.C. in June.

At PCEA, one way we invest in the next generation of rural Iowa leaders is by participating in the National Electric Cooperative Youth Tour program. We're looking for high school sophomores or juniors with a passion for government and public service to apply for a once-in-a-lifetime trip to our nation's capital in June.



One student will be selected from eligible candidates to attend the 2025 Youth Tour in Washington, D.C., from June 15-21 along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as an American citizen. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums, and historical landmarks. Students who go on Youth Tour often call it the trip of a lifetime!

We are accepting Youth Tour applications through March 21. Children of PCEA member-consumers are eligible to apply. The student must be a current sophomore or junior or currently hold the status equivalent to a sophomore or junior in an accredited home-based school. 2024 Annual Meeting Minutes



The Annual Meeting of the Members of the Pella Cooperative Electric Association was held at the Pella Christian High School in Pella, Iowa at 7:00 p.m. on the 2nd of April 2024.

Duane Ver Ploeg, President of the Cooperative, presided and called the meeting to order.

Bryce Arkema, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

An invocation was offered by Director Bryce Arkema.

The Pledge of Allegiance, led by Pella Cooperative's Matt Ainsworth, was next recited by all in attendance.

It was reported by the Secretary, Bryce Arkema, that members present in person (via mailed-in ballots) have been checked and that the following members were present and/or participating in that capacity:

Said members' constituting at least 50 members of the Cooperative, President Ver Ploeg announced that the members in attendance constituted a quorum of the members of the Cooperative.

Board Secretary Bryce Arkema commented on the Notice of the Annual Meeting of Members, together with proof of mailing thereof to all members of the Cooperative, as well as the Minutes of the Annual Meeting of the Members held April 4, 2023, which could be read by him. The meeting notice and proof of mailing were then read. A motion was duly made, seconded, and carried to waive the reading of the Minutes. The foregoing was thereupon declared to be approved and was directed to be filed in the records of the Cooperative.

President Ver Ploeg next recognized various guests in attendance at the meeting. In addition, he introduced board members, spouses, and staff members of the Cooperative.

Thomas Tangen, The Cooperative's 2023 youth tour representative, then gave a well-presented explanation of his trip to Washington, D.C. He concluded his remarks with a thank you to the Cooperative for that opportunity.

The Board President then announced that the report of the Nominating Committee would be read at this time. The Chairman of the Nominating Committee, Ruth De Bruin, then presented the report of the Nominating Committee nominating the following members for directors:

Board President Ver Ploeg directed the Secretary to annex the Certificate of Inspectors of Election to the minutes of this meeting and thereupon declared such members duly elected Directors the Cooperative to hold office for the term specified and until their successors shall have been elected and qualified.

There be no further business, a motion was made, seconded, and unanimously carried to adjourn the meeting.

The PCEA Board of Directors met on December 23 for the December board meeting and discussed the following:

- The Board of Directors approved the operating and capital expenditures budget for 2025. As most expenses continue to rise due to inflationary pressure, the forecast for the cost of purchased power remains stable through the upcoming year. The Board of Directors approved a budget that maintains consistent base rates for our members while still planning for regular maintenance and operational growth.
