

Call 811 Before You Dig!

With the start of the spring season brings spring projects! Keep safety at the forefront of your projects and call 811 before you dig! Here's a refresher on some of our frequently asked questions!

What is 811?

811 is the national call-before-you-dig phone number. Anyone who plans to dig should call 811 or go to call811.com before digging to request that the approximate location of buried utilities be marked with paint or flags so that you don't unintentionally dig into an underground utility line.

When do I call 811?

You should call 811 or use Iowa's 811 center website a few business days before you begin any digging, including common projects like planting trees and shrubs or installing fences and mailboxes. The specific amount of advance notice that you are required to provide varies by type of project.

What info do I need before calling 811?

You will need to know the address of where you plan to dig, including the county and nearest cross street, as well as the type of project you're completing and the exact area on the property where you're planning to dig. Whether you call 811 or make your request online, you'll need the same info.

After I call 811, what do I do?

You need to wait a few days to allow utilities to respond to your request and ensure that all utilities have indeed responded to your request before breaking ground. Once all utilities have marked their buried lines, you should dig carefully around any utility marks and consider relocating projects that are close to buried utilities.

Where does PCEA locate?

When you call 811, only the utilites that are owned by the Cooperative will be located. PCEA will locate any underground services up until the meter. Anything beyond the meter, we cannot locate. The member is responsible for maintaining and locating any wire past the meter. Local electricians are able to locate wire that is not owned by the Cooperative.

And if you spend even five minutes with Tyler — better known by customers and friends as "Tyler the Tile Guy" — you'll understand exactly why this business is different.

"We produce drainage tile — plastic corrugated pipe that goes underground to assist with water movement and management," Rachel explains. "Many of our customers work in agriculture, where it's used in fields for better water management. But we're also growing into the commercial sector, helping support infrastructure for construction and roadways."

At The drainEDGE Company, we offer a wide range of pipe sizes, for use in small-scale projects to major infrastructure. Our drain-

age pipe comes in diameters ranging from 3 inches to 24 inches, designed to fit every job's unique needs. The company's product lineup includes single-wall, dual-wall, flexible dual-wall, and small coils, with coverage across the Midwest — including Iowa, Nebraska, Minnesota, Missouri, and beyond. They primarily sell direct to contractors and some direct to farmers, ensuring that those who need it most get the products quickly and reliably.

A Unique Blend of Expertise

Before he was "Tyler the Tile Guy," Tyler was introduced to the plastic industry back in 2006. It didn't take long for him to see how drainage tile could completely transform agriculture, crop yields, and soil health. With over 17 years of hands-on experience under his belt, he not only learned the business inside and out — he spotted the gaps where customer service and product availability could be better.

Meanwhile, Rachel brought her own valuable experience from executive leadership in healthcare, with a focus on customer care and team development. Together, they blended their strengths to create something unique: a company that's as focused on people as it is on production.
