# Board of Directors Tour CIPCO Summit Lake Facility

The Board of Directors were invited to tour the Central lowa Power Cooperative's (CIPCO) Summit Lake facility for their August 29 board meeting. The Board traveled to Creston, lowa where the gas-powered plant is operated.

In 2021, an expansion project was completed following the demolition of the 68-year-old steam plant. As part of the repowering project, three efficient natural gas-fired reciprocating engines were installed that produces 110MW of power to assist during times of peak energy use.

The new generators are reciprocating piston engines fueled by natural gas. Each turbocharged enginegenerator weighs approximately 400 tons and has 18 cylinders. Each generates 18.8MW, which is equivalent to about 25,000 horsepower. Because the engines run at a very low and constant speed, the engines can start and stop quickly and can be tuned for efficiency.

CIPCO and PCEA remain focused on a balanced and diverse generation portfolio. This expansion encompasses diversity in project geography and fuel sources.





### Meter Testing Scheduled in October

Chad Lankford with Raccoon Valley Electric Cooperative in Glidden will be out testing meters in our service territory this month!

As part of our Cooperative principle of cooperation among cooperatives, we appreciate the support from our fellow Iowa REC.

Chad will be testing meters through the PCEA territory the week of Oct. 14. Don't be alarmed if you see him by your meters and be sure to give him a friendly wave!

PCEA regularly tests and inspects our meters to ensure a high standard of accuracy. It is a rare occasion to find that meter is running fast. More commonly, as meters get older, they slow down. In these cases, a meter will allow more electricity to pass through it than it records. If a meter is found to be registering over or under 2% of the normal conditions of the member's electric load, the member's electric bill will be adjusted up or down to reflect the correction.





## ENERGY EFFICIENCY TIP OF THE MONTH

If you're heading out of town during the holiday season, remember to set your home to vacation mode. You can save energy while you're away by lowering your thermostat a few degrees or creating an "away" schedule with a smart or programmable thermostat. Newer water heaters include a vacation mode setting to help you save on water heating costs, or you can simply lower the temperature manually.

Small actions can also stack up to energy savings. Unplug devices that consume energy when they're not in use, including phone chargers, toothbrush chargers, TVs and gaming consoles.

## Need Help with Your Heating Bill?

The 2024-2025 Low-Income Home Energy Assistance Program (LIHEAP) helps qualifying low-income lowa homeowners and renters pay for a portion of their primary heating costs for the winter heating season. The assistance is based on household income, household size, type of fuel, and type of housing.

#### WHEN TO APPLY:

- Elderly (60+) and/or disabled: Oct. 1, 2024 to April 30, 2025.
- All other households: Nov. 1, 2024 to April 30, 2025.

#### WHAT TO TAKE:

- Proof of Income (for all household members age 18 and over). Depending upon your household income type, income documentation from the past 30 days, the last 12 months, or last calendar year, whichever is easier or more beneficial for you;
- Proof of Social Security Numbers for all household members (documentation required);
- · Most recent heat bill; and
- Most recent electric bill.

Wage Earners: Please bring copies of your check stubs for the 30-day period preceding the date of application, or a copy of your most recent federal income tax return

Fixed Income: This income may include Social Security Benefits, Supplemental Security Income, Family Investment Program, Veteran's Assistance, Unemployment Insurance, and pensions. Please bring copies of your check stubs from the previous 30 days.

Self-Employed/Farmers: Please bring a copy of your most recent federal income tax return.

FIP Recipients: Please bring your current DHS Notice of Decision or contact your local office for acceptable document information.
