## Pella Cooperative Electric Association Annual Meeting of Members

The Annual Meeting of the Members of Pella Cooperative Electric Association was held virtually from the Cooperative's headquarters' office in Pella, Iowa, at 8:00 a.m. on the 6<sup>th</sup> day of July 2020. (The Annual Meeting was video recorded on this date and will be available electronically to all who wish to view it in that manner. A print version of the meeting minutes will also be available on the Cooperative's webpage, as well as available to member's requesting them from the Cooperative's headquarters office Pella, Iowa.)

Duane Ver Ploeg, President of the Cooperative, presided and called the meeting to order.

Bryce Arkema, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

An invocation was offered by Director Bryce Arkema.

The pledge of allegiance, led by Pella Cooperative's Lance Freml, was next recited by all in attendance.

It was reported by the Secretary that an adequate number of member ballots had been received to satisfy the Cooperative's Bylaws quorum requirement (10% or more of members of the Cooperative represented by mail ballots.)

President Ver Ploeg announced that the members' ballots received (10% or more of the total Cooperative members) constituted a quorum of the members of the Cooperative.

Board Secretary Bryce Arkema next offered to have the Notice of the Annual Meeting of Members, together with proof of mailing thereof to all members of the Cooperative, as well as the Minutes of the Annual Meeting of the Members held April 2, 2019, read by him. The meeting notice and proof of mailing were then read. A motion was duly made, seconded and carried, to waive the reading of the Minutes. The foregoing was thereupon declared to be approved and was directed to be filed in the records of the Cooperative.

The Chairman announced that the report of the Nominating Committee would be read at this time. Fred Dorr, attorney for the Cooperative, then presented the report of the Nominating Committee, nominating the following members for directors:

A vote for directors was then had by ballot, and the mail ballots were delivered to the Inspectors who proceeded to count the same.

Thereafter, Board President Duane Ver Ploeg and the Cooperative's Assistant Manager Doug Stewart reported on operations of the Cooperative.

Retiring Director Norman Van Zante was next recognized and thanked for his many years of service to the Cooperative as a Pella Cooperative Board Member. Best wishes were extended for a long and enjoyable retirement.

The Certificate of Inspectors of Election was then presented and read by the Cooperative's legal counsel, Fred Dorr, certifying that the following members receiving the highest number of votes cast, had been duly elected Directors of the Cooperative to hold office for the term specified and until their successors shall have been elected and qualified:
